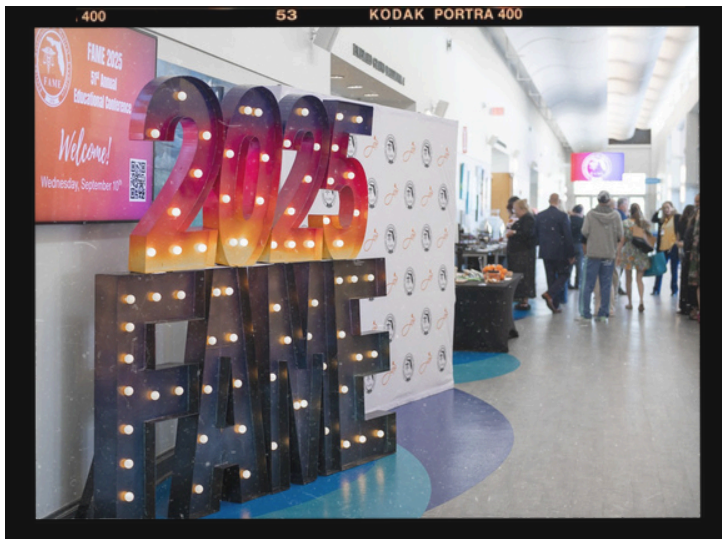

# GENERAL INFO for Exhibitors & Sponsors



## Assignment of Space & Payment

All exhibit space will be allocated on a first - come, first - served basis. Confirmation of space will be sent immediately upon receipt of a signed contract and full payment. All advertising materials, company listing information and any applicable contracts for exhibit space must be submitted and acknowledged no later than May 15, 2026. The Florida Association of Medical Examiners (FAME) reserves the right to re-assign table space if necessary. Payment in full is due within 30 days of the contract submission if requesting check payment. Exhibition table assignment will be released if payment is not received within 30 days. No exhibitors shall assign, sublet, or share the whole or any part of the space contracted with any other company without prior written consent from FAME. All exhibit requests are due by May 30, 2026

## Exhibition Space Specifications

The standard booth configuration is 10'x10' and includes an 8' table and 2 chairs. Additional furnishings, electrical and internet services may be available for purchase and must be purchased directly from Hard Rock Hotel Daytona Beach.™

## Additional Exhibitor Tickets and Name Badges

Each exhibitor package includes two (2) badges which includes entry to the conference. Additional vendor badges are available for purchase for \$400.00 per additional attendee.

Guest Passes for an additional guest who will only have access to evening events are also available for \$300.00 per pass per person.

## Cancellation Policy

Exhibitors and Vendors may reduce or cancel contracted space by submitting written notice to Karla Orozco at [korozco@volusia.org](mailto:korozco@volusia.org). Such notice must be received and acknowledged no later than May 30, 2026. Exhibitors cancelling an entire exhibit space after May 15, 2026 shall be charged an administrative fee of 25% of the total cost of the display space. Cancellation requests made after May 30, 2026 shall be charged an administrative fee of 50% of the total cost of the display space. No refunds will be made if written cancellation or reduction request is not received by July 15, 2026.

# GENERAL INFO for Exhibitors & Sponsors



## Restrictions

FAME reserves the right to determine eligibility of a company and their product for inclusion in the exhibits at the FAME 2026 Educational Conference. FAME reserves the right to restrict exhibits that, because of noise, method of operation, materials or for any other reason, become objectionable to FAME. FAME also reserves the right to prohibit any exhibit that, in the opinion of FAME Management, may detract from the general character of the exhibit show as a whole. FAME reserves the right to prohibit any exhibit where the exhibiting company's products and services do not directly relate to the medicolegal industry. In such an event, any exhibitor terminated prior to expiration of the symposium for cause shall not be entitled to a refund or entitled to damages for any direct or indirect expenses incurred by the exhibitor. The exhibition of a company's product or services within the FAME conference does not represent an endorsement of those products or services by FAME. No signs will be affixed by any means to the walls, doors or any other surface in the exhibit area. FAME policy firmly restricts representation of an organization that has not been assigned an official exhibit table from soliciting business and/or distributing promotional material of any type within the exhibit area or any other areas assigned to FAME by the Hard Rock Hotel<sup>TM</sup>. Further, those organizations that have been assigned an official FAME exhibit table must conduct all business activities from within their assigned table space and may not impede traffic through the exhibit hall isles and other areas. No one is permitted into the exhibit area during installation times except for authorized personnel (those with vendor/exhibitor badges) who are working or supervising the installation of tables, equipment or furnishings. Absolutely no children under the age of sixteen (16) will be admitted during set up. break down or at any other time.

## Liability

Exhibitors and vendors, including their respective officers, directors, members, employees, agents, contractors, representatives, successors, assigns, and insurers, shall fully indemnify, defend, and hold harmless the Florida Association of Medical Examiners (FAME), the Hard Rock Hotel, and each of their respective parent companies, affiliates, subsidiaries, vendors, officers, directors, employees, agents, representatives, successors, assigns, and insurers from and against any and all claims, demands, causes of action, suits, damages, losses, liabilities, judgments, penalties, fines, costs, and expenses of any kind whatsoever, including, without limitation, reasonable attorneys' fees and court costs.

This indemnification obligation shall apply to any and all losses, injuries (including death), damages to persons or property, theft, accidents, incidents, or other occurrences, whether foreseen or unforeseen, arising out of, relating to, or in any way connected with the exhibitor's or vendor's participation in the conference, occupancy or use of the premises, transportation of materials, installation or removal of exhibits, or the acts or omissions of the exhibitor or vendor, or anyone acting on their behalf, regardless of whether such claims are caused in whole or in part by the negligence of FAME, the Hard Rock Hotel, or any other indemnified party, except to the extent prohibited by applicable law. The obligations set forth herein shall survive the conclusion of the conference and any termination of the exhibitor's or vendor's participation.
